

The City of Lowell's Holiday Shopping Sweepstakes OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO WIN.** To enter The City of Lowell's Holiday Shopping Sweepstakes print your name, address (including zip code), home and work telephone numbers and email on a registration form (available at Barnes & Noble or The Lowell Chamber of Commerce) or on a postcard and mail to: The City of Lowell's Holiday Shopping Sweepstakes c/o Single Source, P.O. The City is not responsible for late, lost, misdirected, altered, incomplete or illegible entries. By entering this sweepstakes, entrants accept and agree to be bound by these rules and the decisions of the judges, which shall be final on all matters.
